Pursuant to the Stipulation Regarding Injunction dated October \_\_\_\_\_, 2020 executed by and between Plaintiff BidPrime, Inc. ("BidPrime") and Defendant Ramsey County ("Ramsey County"), the Court hereby orders:

- 1. **Definitions.** "Government data" is defined in Minn. Stat. § 13.02, Subd. 7.
- 2. Injunction.
  - a. Upon BidPrime's written request to Ramsey County, Ramsey County shall provide BidPrime with the following public government data: solicitations and any addenda thereto. This data shall be provided as soon as reasonably possible and no more than five (5) business days from the date of the request.
  - b. Any requests for data by BidPrime, set forth in section 2.a., above, shall be directed to all of the following mailboxes:

DataRequests@co.ramsey.mn.us;

ProcurementTeam@co.ramsey.mn.us; and

donna.knutson@co.ramsey.mn.us.

c. At such time as Ramsey County makes requested solicitations and addenda

material publicly available through its website or other Ramsey County

online platform, Ramsey County may direct BidPrime to the County's

designated site to obtain the requested data in lieu of the mechanism set forth

in paragraphs a. and b., above.

d. The scope of this injunction is limited to solicitations and addenda. Any

other public government data requested by BidPrime shall follow the

County's public data request process by sending an email to both of the

following email addresses:

DataRequests@co.ramsey.mn.us; and

ProcurementTeam@co.ramsey.mn.us.

The County will respond to those requests in a prompt and appropriate

manner as required by Minn. Stat. § 13.03, subd. 2, and Minn. R. 1205.0300.

3. Retention of jurisdiction. The Court retains jurisdiction to enforce the

terms of this injunction for two (2) years from the date of this Order.
